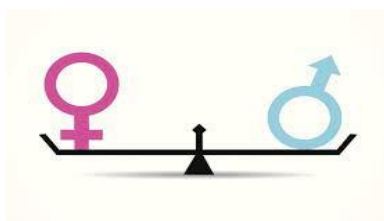

Yeshwant Mahavidyalaya, Nanded is established by Shri Sharda Bhavan Education Society in 1963. The college is affiliated to Swami Ramanand Threeth Marathwada University, Nanded. The College offers graduation, post graduation and Ph.D. Courses in Arts, Commerce and Science. In addition to the regular courses, the college has started Career Oriented Course and Add-on programs.

The college always concentrates on student's qualitative performance along with their overall personality development. Observing the gender equality, the girls are provided with various facilities and special attentions. The College has Gender Sensitivity Cell, Mahila Suraksha, Sudhar Samiti and Internal Complaints Committee under IQAC. The NSS has separate unit of girls. The unit always motivates girls for their social responsibilities. Special study room, waiting room and girls hostel are provided for the girls. They are also given self-defence trainings by Mahila Suraksha, Sudhar Samiti with the help of Nanded police. The lectures of eminent personalities are held on various topics to develop their personalities. Girls are made aware of laws by organizing lectures of eminent judges and lawyers by Gender Sensitivity Cell and Mahila Suraksha, Sudhar Samiti. The analysis of the responses of students with regard to courses and programs in college and its activities revealed that most student members feel that the gender equity in policies, programmes of the college is adequate.

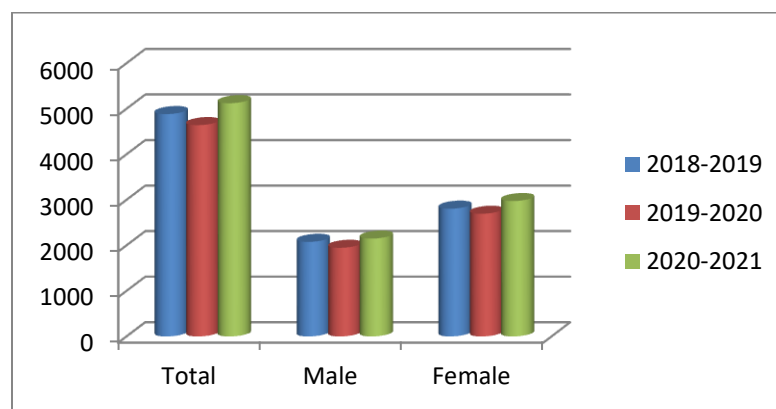

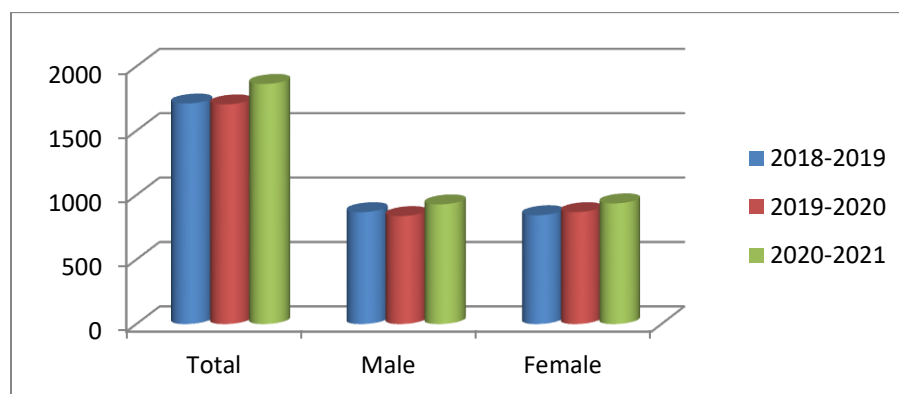
***Figure No.1: Gender wise Details of Total Students in the College***

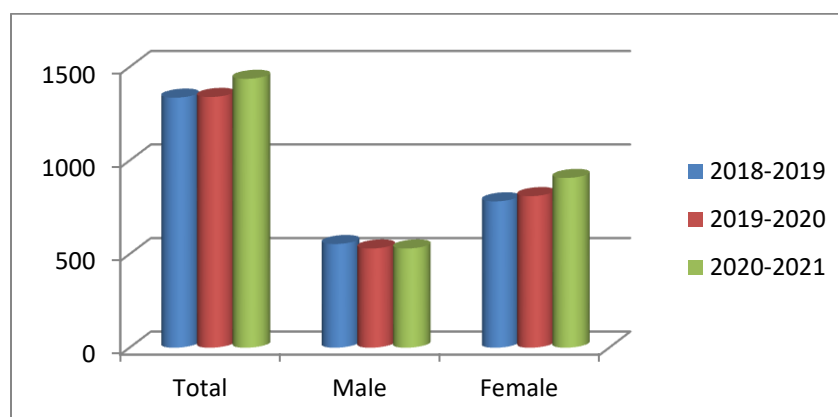
**Figure No.2: Gender wise Details of Total students in Arts**

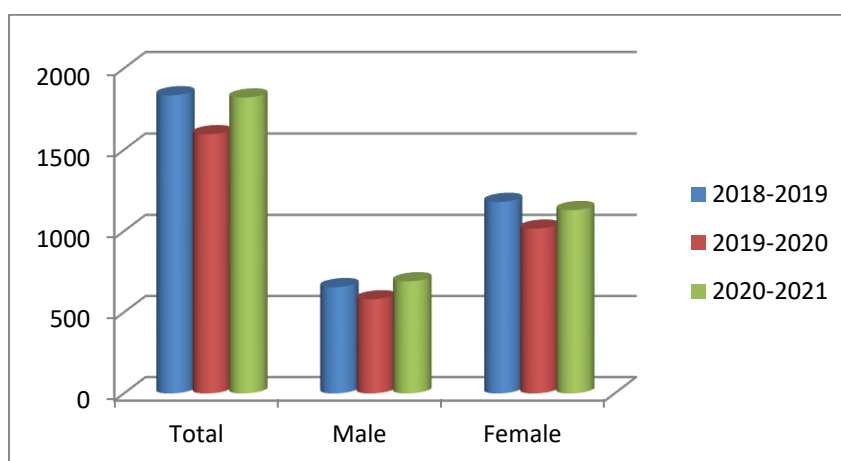


**Figure No.3: Gender wise Details of Total students in Commerce**

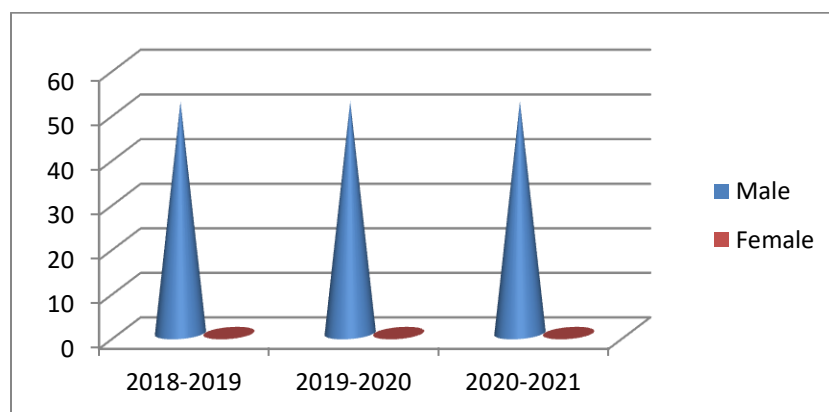
**Figure No.4: Gender wise Details of total students in Science**

**Figure No.5: Gender wise Details of total students in NCC**

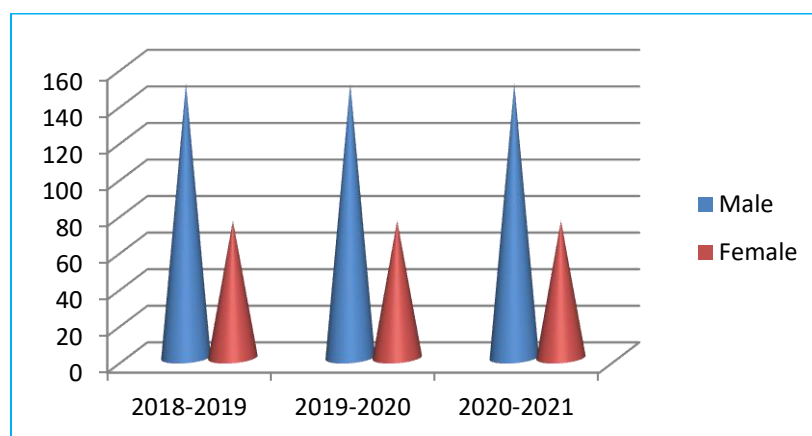

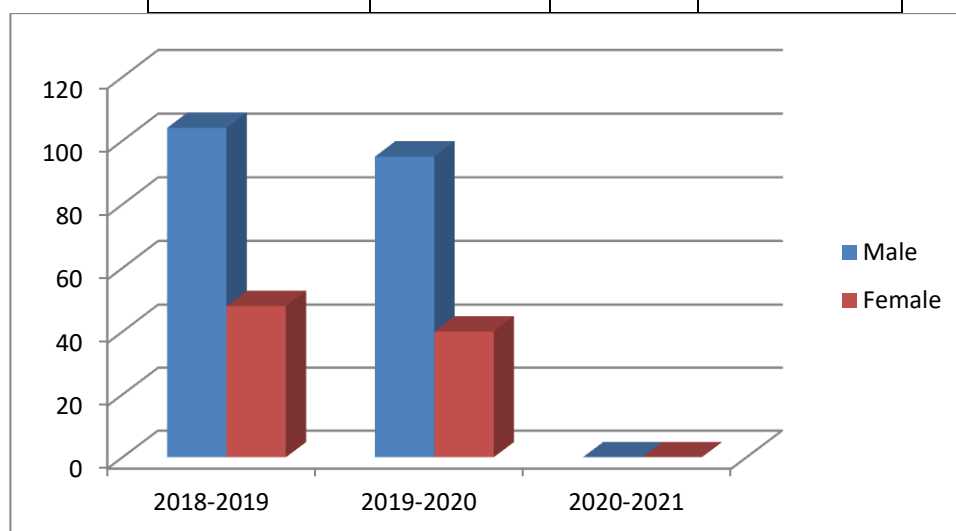


**Figure No.6: Gender wise Details of total students in NSS**

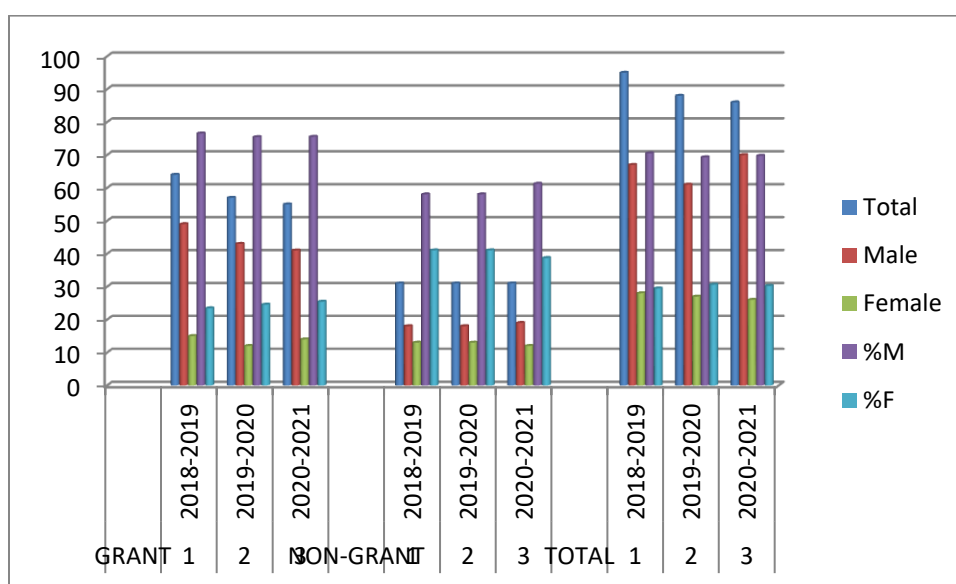
**Figure No.7: Gender wise Details of total Participants in College Sports**

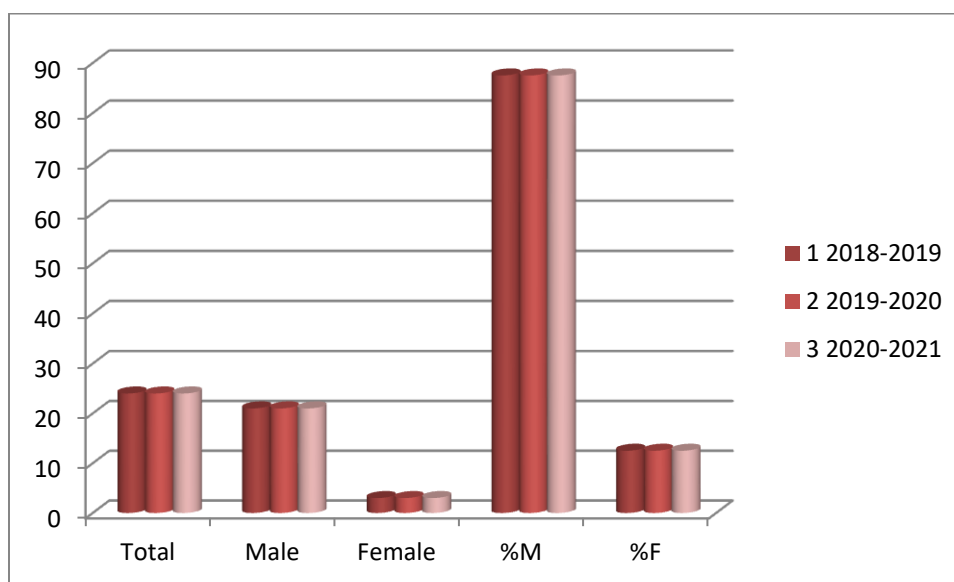
**Figure No.8: Gender wise Details of Teaching staff in College**

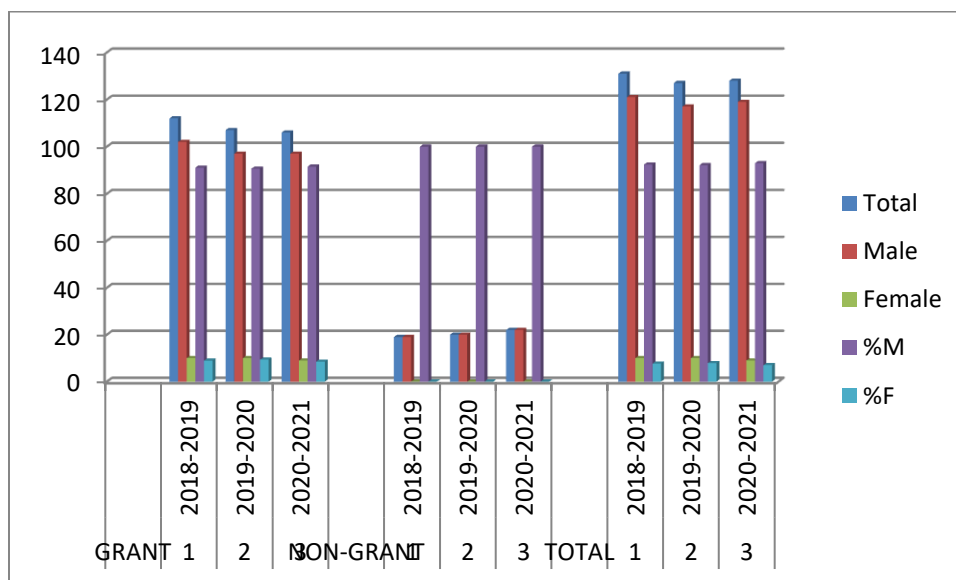
**Figure No.9: Gender wise Details of total HODs in College**

Contacting students in regular mode was not possible due to influence of COVID Pandemic almost throughout the academic year 2020-21.

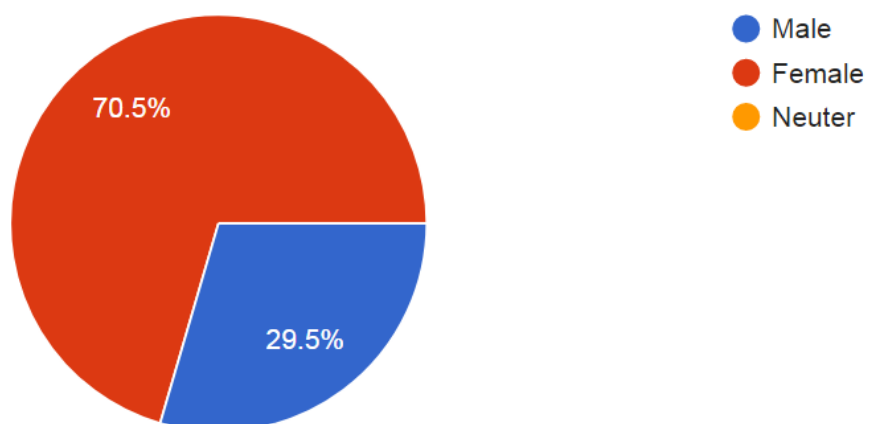

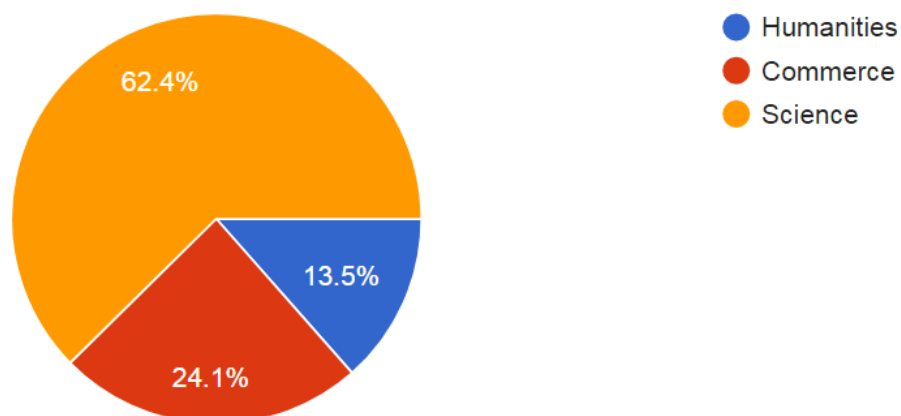

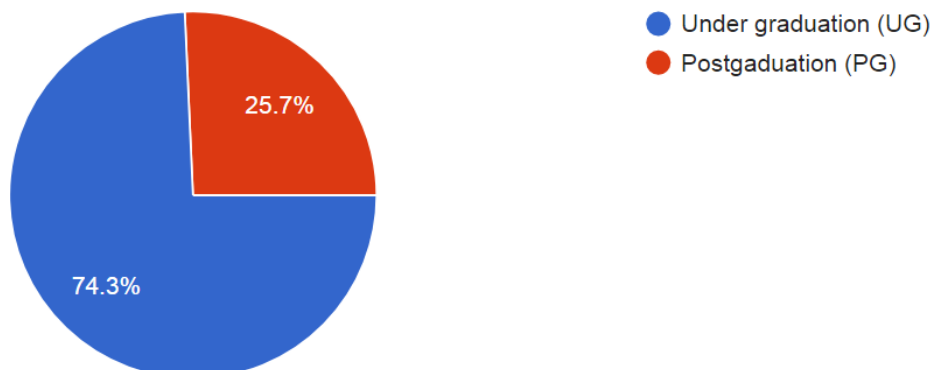

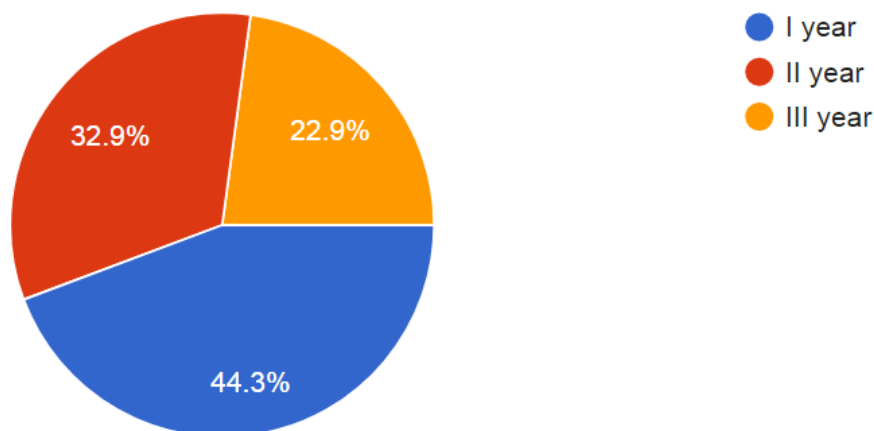

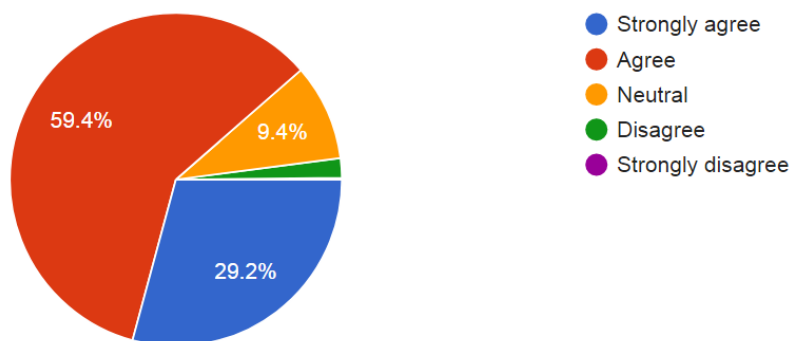

Does the college make adequate security provisions to ensure safety of the students on the campus?

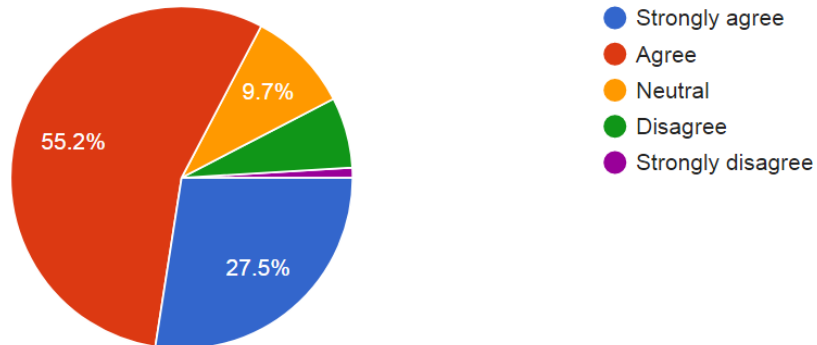

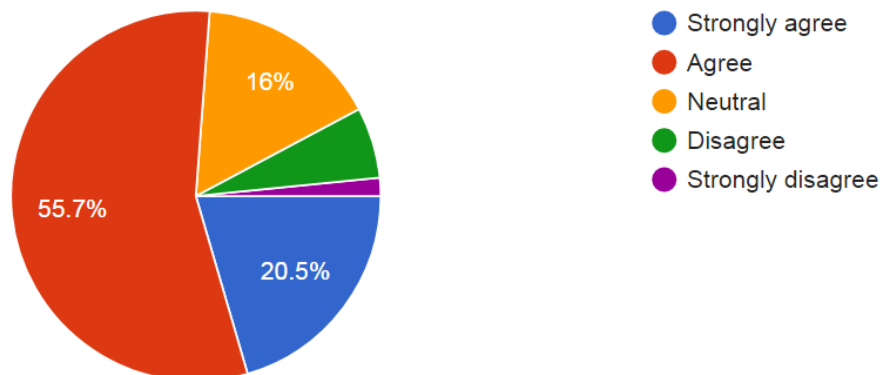

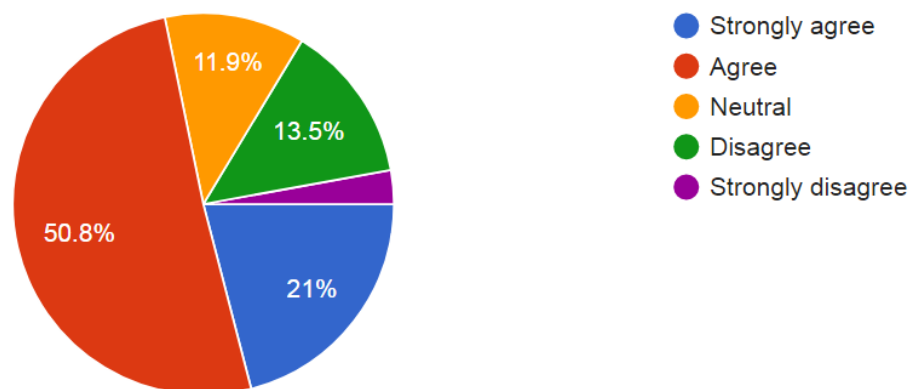
Does the College have adequate lighting available inside the campus during night?

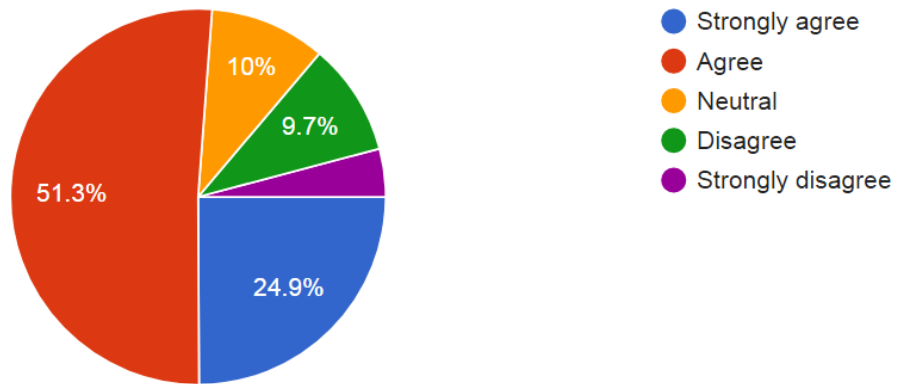

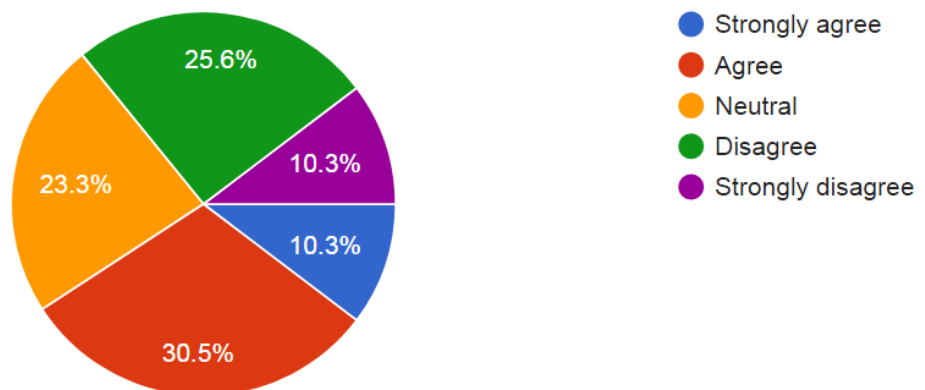
Does the College have sufficient washrooms for the students on the campus?

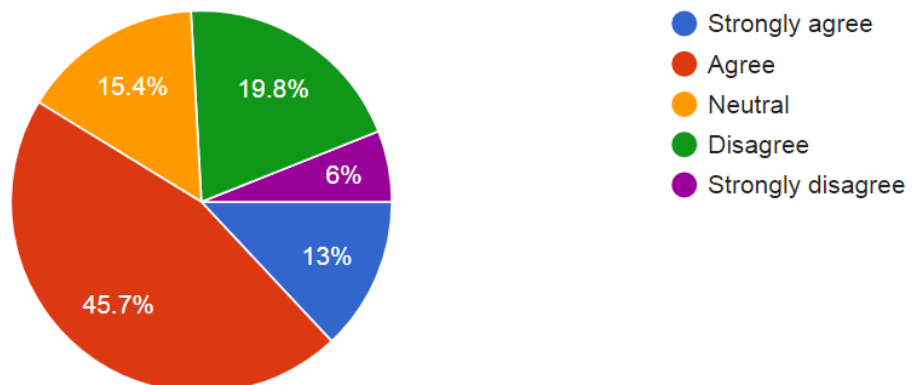
Do you know about the availability of sanitary napkins on the college campus?

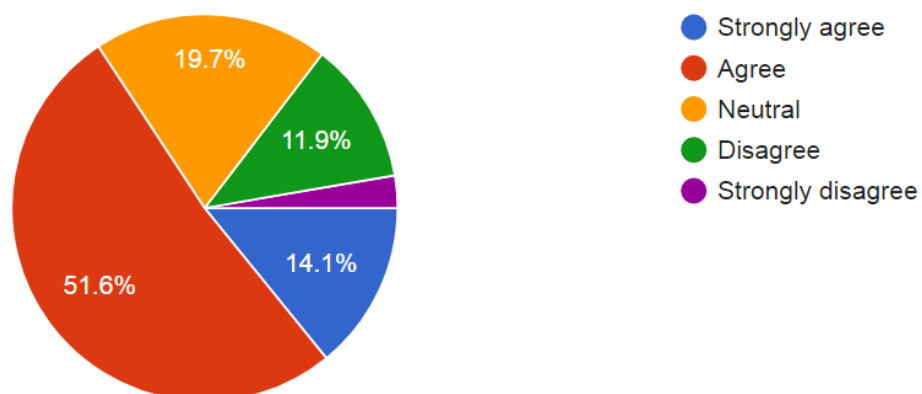

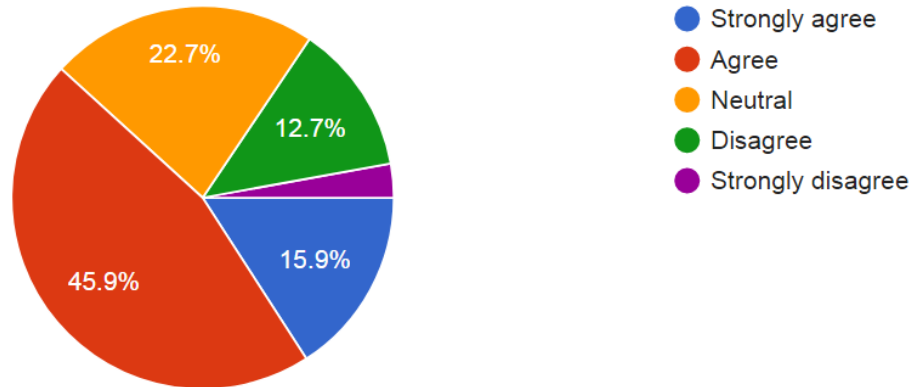

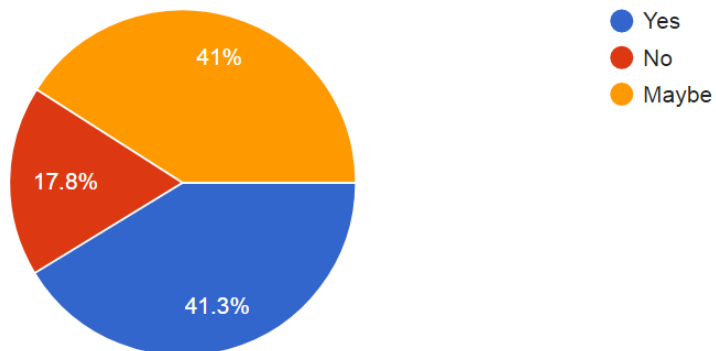

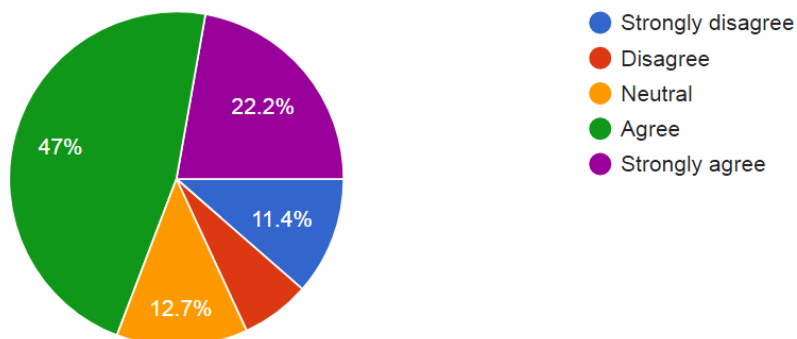

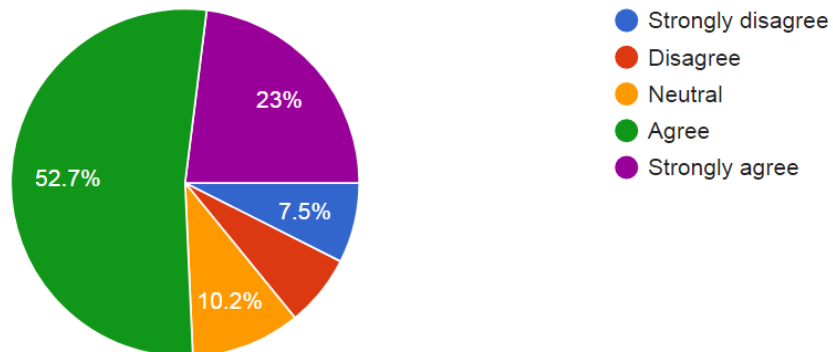
Do you agree that the college organizes Curricular and co-curricular activities that have equal opportunities for both the genders?

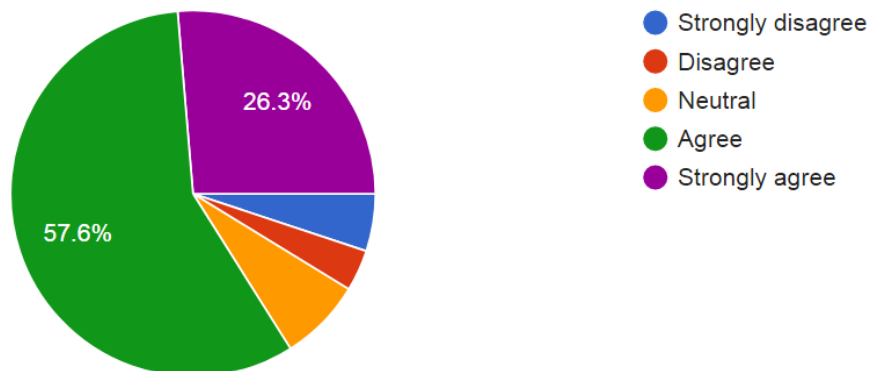

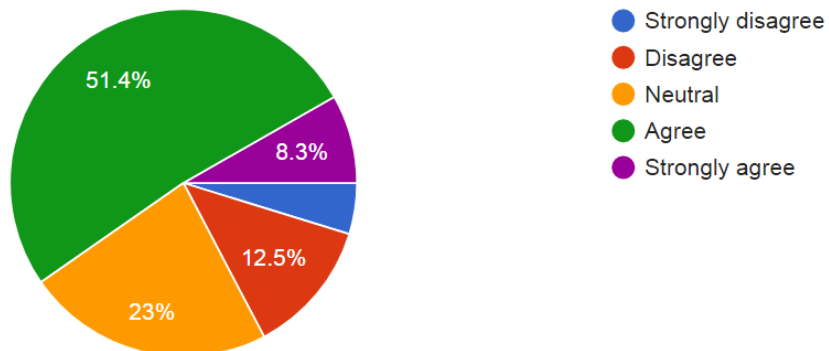
Do you attend the gender sensitization programs organized by the college as a part of its curriculum?

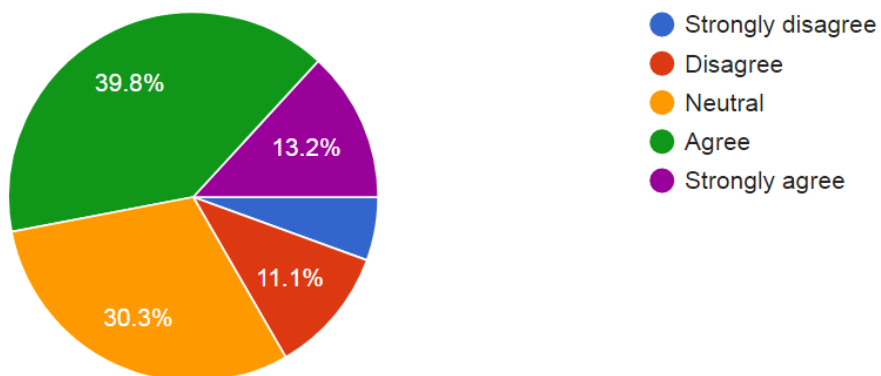

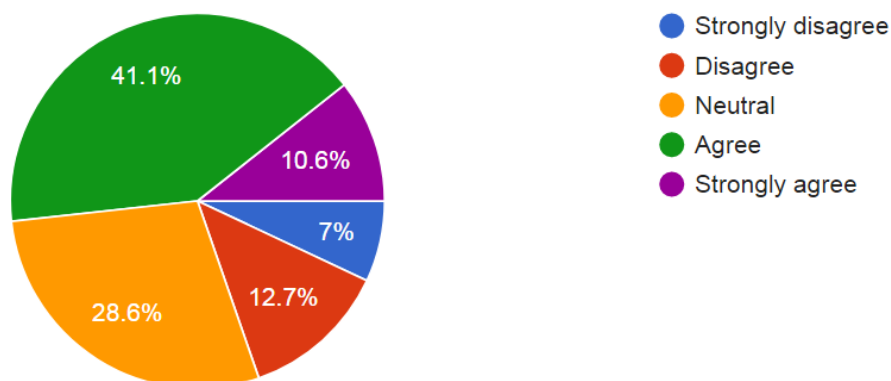
Is the college girls' hostel maintained properly?

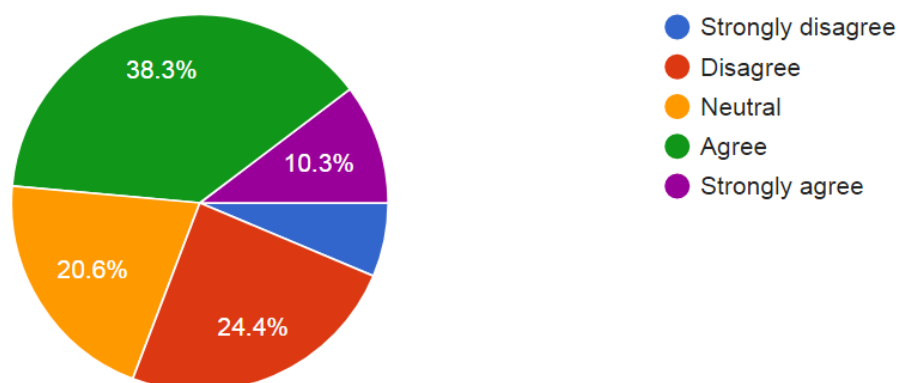

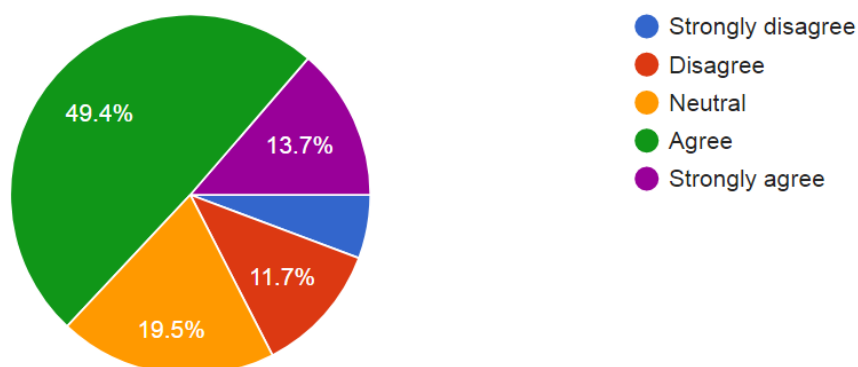
